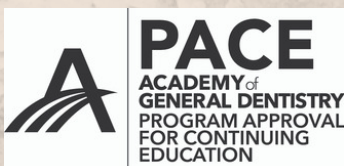

HE MAINTAINS AN INTERDISCIPLINARY FACULTY INTRAMURAL PRACTICE LIMITED TO RESTORATIVE AND IMPLANT DENTISTRY AT THE UNIVERSITY OF IOWA COLLEGE OF DENTISTRY.
